



## **CLARE KETON TATTOOS TERMS AND CONDITIONS**

### **PREPARATIONS FOR YOUR TATTOO**

- DO NOT consume drugs or alcohol within 24 hours of getting a tattoo work
- A good nights sleep is recommended
- Make sure you have something substantial to eat within 2 hours prior to the appointment
- NO ALCOHOL is to be brought onto the premises
- Do not wax or shave the area prior to the appointment
- Area to be tattooed must not be sun burnt or peeling
- If you are unwell (including cold or flu) I will not tattoo you. Please call as soon as you get sick, not on the day of your appointment

## DRAWING

- Base drawing fee is required for large scale work and smaller scale or custom pieces
- Drawings will not be started unless the booking/s for a tattoo have been made
- Drawing is not given if appointment/s are cancelled
- Copies of drawings cannot be faxed/mailed unless 50% of the tattoo price is left and is not refundable
- The drawing fee includes changes to one drawing only
- If you change the subject of the drawing a new drawing fee is due
- No refund is given on drawing fee once design consultation is done. This also applies if tattoo is not started or if appointments are cancelled

## TATTOOING

- I offer 10% discount to clients who refer a book in
- I charge strictly by the hour for outline sessions due to the nature and intensity of the work
- If your tattoo is a large piece the minimum session time will be 5 hours
- Large scale OR ongoing work - a deposit is required to secure your booking
- Smaller pieces - a deposit is required to secure your booking
- Deposit is deducted from the final tattoo appointment fee
- Deposits are not refunded if the tattoo is not finished. If you know you are unable to finish the tattoo please don't begin the work with me as a lot of time, effort and love goes into each individual piece
  
- Deposit and drawing fee are to be transferred to my bank account, all other payments are strictly cash only
- PAYMENT MUST BE MADE ON THE DAY OF YOUR TATTOO APPOINTMENT, STRICTLY CASH ONLY
- I require two week's notice when changing or cancelling appointments, otherwise your deposit is forfeited
- If appointments are postponed for more than 6 months another deposit is required
- I reserve the right to use photos of artwork and tattoos for promotional purposes
- Any abusive, aggressive, drug or alcohol affected client conduct will result in refusal of service and void deposit refund
- My studio is not a child friendly environment, please do not bring your children to appointments
- Due to limited space in the studio guests cannot be accommodated
